RE: 2020 Chloride Application for Dust Control

It's time again for Milton Township residents to order chloride for dust control on the roads. We will be following the same procedure for ordering chloride as we have for the last several years.

We want to remind you that we do not guarantee that the chloride will provide a completely dust-free environment. We do our best to make sure the chloride is applied in the best possible weather conditions. We provide a planned date, but changes can happen based on weather and the vendor's schedule. We will continue to use Freeborn County Coop as the vendor for our chloride. The cost of chloride will increase slightly this year, due to an increase in cost to us: \$.45/foot for 12 foot wide; \$.57/foot for 18 foot wide.

The chloride is currently scheduled to be applied on May 29th. As you know, weather can cause that date to be changed. I will send emails about any updates, and will also put a notice on the website: www.milton-township.com.

If you want to have chloride applied to your road, please do the following:

- 1) Pick up stakes at the town hall to mark where you want chloride applied. The stakes are in a barrel by the town hall door. If you are ordering 12 ft. wide chloride, take two stakes. If you are ordering 18 ft. wide chloride, take four stakes.
- 2) Put one stake at the beginning and one stake at the end of the area where you want the chloride applied. If you are ordering 18 ft. wide, put two stakes at the beginning and end of where you want it applied, crossed like an X. Measure the distance between the stakes. That will be the length of area that you want chloride applied. Please measure accurately.
- 3) If you want to know how many feet you ordered last year, send me an email and I will let you know. My email address is clerk@milton-township.com. Or call or text me at (507)254-5545.
- 4) Fill out the enclosed/attached form. If you are ordering chloride for more than one location, please fill out a separate form for each location. Figure out your cost based on the number of feet you want, and the cost per foot.
- 5) Send the form with a check for the amount indicated on the form to:

Your order form and check must be received by the township by May 22nd, 2020. Please have your stakes in the ground by Monday, May 25th.

Again, the chloride is on the schedule to be applied on Friday, May 29th. Check Milton Township's website or watch for emails about any changes to that plan.

- 6) If you are sharing the cost of chloride with another person/s, figure each person's share and send both checks together with one order form.
- 7) The chloride truck, which has GPS, will dispense chloride between your stakes for the exact number of feet you ordered and paid for. So please be sure you measure between your stakes correctly.
